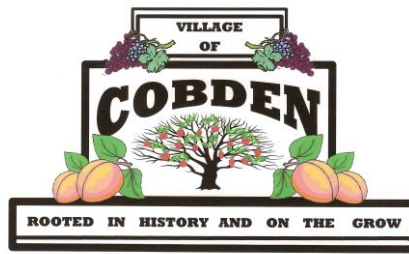

### Cobden Political Trivia

This November will mark Karen Winzenburger's 40<sup>th</sup> year as Cobden Village Clerk. Karen was hired as a full-time Village employee in August 1974. She was appointed Village Clerk in April 1975 when the current Village Clerk, Jo D. Lamer, resigned from office. Karen served until May 1984 when she resigned due to moving outside the Village limits. Mildred Chapman served for one year as Clerk and June Hilligoss served from May 1985 to November 1986 when she resigned. Karen then moved back into the Village limits and was appointed to replace Hilligoss. She has been re-elected to the position ever since. Two other long-serving Village Clerks were Ira Casper (July 1942- February 1971) and Lee Sumner (May 1924-July 1942). Congratulations to Karen for her dedication to the Village and to this office.

The following bits of Village government trivia might be interesting to you.

In December of this year, Maria Braden will have served as Deputy Village Clerk for fifteen years which makes her the longest serving Deputy Village Clerk.

When Paul Tomazzoli finishes his second term in 2021, he will be the first mayor since Everett Randall to be elected to and to serve two complete consecutive terms (1953-1961).

William Fry was elected mayor three different times (1973, 1977, 1985) but did not complete the four year term for 1977 and 1985).

Homer Forby served as Village Trustee, Mayor and Treasurer; probably the only person to do so. He served twice as mayor (1979-1985 and 1997-2001).

Blake Broadway served 18 years as mayor (1931-1949); probably longer than anyone else.

The Village currently has five former mayors still living: Homer Forby, Gene Dammerman, Patrick Brumleve, Elvis Pearson, Wes Lyerla, and Molly Beckley.

Jack Williams served 11 years on the Village Board and 36 years as Treasurer for a total of 47 years of service to the village.

Truman Sitter served a total of 32 years on the Village Board.

Penny Basler was the first woman elected to the Village Board in 1975. Women have been on the Village Board from 1975 to 1979, 1981 to 2003, 2005 to 2007, 2009 to present. At one time during 1994-95, three women served on the Village Board. No other community in Union County has seen this kind of service by women.

Molly Beckley was the first woman to be elected mayor in 2009.

Patrick Brumleve was elected to the Village Board at the age of 18 while still in high school in 1977. He is tied with Truman Sitter for most years on the Village Board and also served one term as mayor.

### **Cobden Veterans Memorial**

In 2004, a group of community members formed a committee to erect a memorial to Cobden's veterans. With donations from businesses, community organizations and individuals their goal was reached. At the time the monument was placed in the Cobden Community Park, the names of 590 veterans were inscribed on the monument. The number of names on the memorial now total 700 with several more names to be inscribed in the near future.

It has now become necessary to expand the monument because there will soon be no space to add names. An estimate of approximately \$3,500 has been given to add two pillars to the memorial. The current balance in the Cobden Veterans Memorial fund is \$3,165 which is not sufficient for the cost of the new pillars. The expense of adding names to the monument is paid by the Village (\$50 per name). Sole income for the fund is from donations and proceeds from Memorial Day and Veterans Day banners. Expenses related to the memorial are for lighting, insurance, replacement flags, and engraving of names.

We hope you will be able to make a contribution to the fund to assist us in our efforts to honor our local veterans.

**NATURAL GAS**

Mercaptin is the harmless chemical we add to natural gas so you can detect even the smallest amount of gas which might escape. If you ever smell faint whiffs of this odor check to see if a pilot light is out, or if a burner valve is partially turned on. If you cannot find the source, call us at once. If the odor is extremely strong, evacuate the premises immediately. Don't light a match or switch anything on or off. Call us from the nearest telephone outside the building at once.

Natural gas is not poisonous. However, when you burn gas or any fuel, carbon monoxide can be produced by lack of air, improperly working appliances or bad flue conditions. As a basic precaution be sure that flue connections and venting are always unobstructed and that appliances are in proper working order.

**EL GAS NATURAL**

Mercaptin es una sustancia quimica que no dana y que agregamos al gas natural para que usted sepa cuando haya el mas minimo escape de gas. Si alguna vez usted huele un olor como este, por mas leve que sea, vea que ningun piloto este apagado, o que ninguna valvula de quemador este medio abierta. Si no encuentra el escape, llamenos cuanto antes. Si el olor es demasiado fuerte, alejese del lugar inmediatamente. No encienda cerillos, ni prenda o apague ningun conmutador (switch) electrico. Llamemos cuanto antes del telefono mas cercano.

El gas natural no es venenoso. Pero, cuando usted usa gas o cualquier otro combustible, el monoxido de carbono puede ser producido por la falta de aire fresco, por asparatos domesticos que no funcionan bien, o porque los ventiladores de aire estan en malas condiciones. Como precaucion basica debe asegurarse que las conecciones y la ventilacion no esten obstruidas, y que los aparatos domesticos funcionen bien.

### **ZONING APPLICATIONS (Building Permits)**

Within the corporate limits of Cobden, no building and/or structure shall be enlarged or constructed (including pre-manufactured storage buildings), or the construction commenced until a Zoning Application has been approved by the Village Board. An application can be obtained at the Village Hall, completed by you, and returned to the Village Hall office.

The application is forwarded to the Village Superintendent who will review the effect the project may have on Village utilities. It is then referred to the Village's Zoning Administrative Officer for review. Following these reviews, the application is then presented to the Village Board for its consideration at its next regular meeting.

**Construction is not to begin until the permit has been approved by the Village Board of Trustees.** Because of the required site inspection, application must be made at least ten (10) working days prior to the Village Board meeting.
